Whereupon, the Mayor declared the following Resolution duly adopted:

ORDERING RESOLUTION CONSTRUCTION OF THE HUBBARD POOL. **SWIMMING** AND RATIFYING. CONFIRMING AND **APPROVING DEADLINE** FOR SUBMISSION OF BIDS AND FIXING A DATE FOR HEARING THEREFOR

WHEREAS, it is deemed advisable and necessary to construct certain public improvements described in general as the Hubbard Swimming Pool; and

WHEREAS, the City has caused to be prepared plans, specifications and form of contract, together with estimate of cost, which are now on file in the office of the City Clerk for public inspection, for the construction of the public improvements; and

WHEREAS, the plans, specifications and form of contract are deemed suitable for the making of the public improvements; and

WHEREAS, before the plans, specifications, form of contract and estimate of cost may be adopted, and a contract for the construction of the public improvements is entered into, it is necessary, pursuant to Chapter 26, Code of Iowa, to hold a public hearing and to advertise for bids; and

WHEREAS, on or about June 29, 2022, an Invitation to Bid was posted on a relevant contractor plan room service with statewide circulation and a relevant construction lead generating service with statewide circulation establishing 2:00 P.M. on July 14, 2022 as the deadline for submission of bids; and

WHEREAS, on or about June 27, 2022, an Invitation to Bid was posted on an internet site of a statewide association that represents the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUBBARD, STATE OF IOWA:

Section 1. That it is hereby determined that it is necessary and advisable to construct certain public improvements described in general as the Hubbard Swimming Pool, in the manner set forth in the plans and specifications and form of contract, above referred to, the cost thereof to be paid in accordance with the provisions as set out in the posted Notice to Bidders and published Notice of Public Hearing; the public improvements being more generally described as follows:

Construction of a new outdoor aquatic center, consisting of a swimming pool having a water surface area of 3,600 sq. ft. Water features include one-meter springboard diving and other related items. Building structures include a 960 sq. ft. bathhouse and a 824 sq. ft. filter building. Site work includes walks, fencing, concrete deck, and other site related work. The swimming pool will be constructed at 701 East Ash Street, Hubbard, IA.

Section 2. That the amount of the bid security to accompany each bid shall be in an amount which shall conform to the provisions of the notice to bidders approved as a part of the specifications.

Section 3. That the actions of the Project Manager in posting a Notice to Bidders once in a relevant contractor plan room service with statewide circulation and a relevant construction lead generating service with statewide circulation and on an internet site sponsored by either the City or a statewide association that represents the City, are hereby ratified, confirmed, and approved.

Section 4. That the actions of the Project Manager in setting a date for the receipt of bids before 2:00 P.M. on July 14, 2022 are hereby ratified, confirmed, and approved.

Section 5. That the City Council hereby delegates to the City Clerk or her designee the duty of receiving, opening and tabulating bids for construction of the Project. Bids shall be received and opened as provided in the public notice and the results of the bids shall be considered at the meeting of this Council on July 25, 2022, at 5:00 P.M.

Section 6. That the City Clerk be and is hereby directed to publish notice of hearing once in a legal newspaper, printed wholly in the English language, published at least once weekly and having general circulation in this City. Publication shall be not less than four clear days nor more than twenty days prior to the date hereinafter fixed as the date for a public hearing on the plans, specifications, form of contract and estimate of costs for the project, the hearing to be at 5:00 P.M. on July 25, 2022.
