RESOLUTION ACCEPTING THE SANITARY SEWER
REHABILITATION - PHASE 3

WHEREAS, on the 13 day of September, 2021 the Mayor and Clerk of the City of Hubbard, Iowa, entered into a construction contract with Municipal Pipe Tool Co. of Hudson, Iowa, for the construction of certain public improvements generally described as the Sanitary Sewer Rehabilitation - Phase 3; and

WHEREAS, the contractor has fully completed the construction of the public improvements in accordance with the terms and conditions of the contract and plans and specifications, as shown by the certificate of the Engineer filed with the Clerk on July 11, 2022 :

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUBBARD, STATE OF IOWA:


Section 1. That the report of the Engineer be and the same is hereby approved and adopted, and the public improvements are hereby approved and accepted as having been fully completed in accordance with the plans, specifications and form of contract and the total final construction cost thereof is hereby determined to be \$ 234,804 , as shown in the report of the Engineer.
